

**Memorandum of Understanding  
On ACADEMIC COLLABORATIONS**

**Between**

**Government Raza P G College, Rampur, 244901,  
(U.P.), India**

**and**

**IFTM University,  
Lodhipur Rajput, Delhi Road, Moradabad, 244102,  
(U.P.), India**

This Agreement is made and entered on Dec, 06 in the year 2023 between:  
**Government Raza P G College, Rampur, 244901 (U.P.), India (I<sup>st</sup> Party)**

and

**IFTM University, Moradabad, 244102 (U.P.), India (II<sup>nd</sup> Party)**

The aforesaid institutions are hereinafter referred to individually as Higher education institution (HEI).

### **Preamble**

Whereas, **Government Raza P G College, Rampur** have many areas of common interest in the Faculty of Arts, Science, Commerce and Education considerable advantage may be gained from their pursuit on a collaborative basis in the fields of education and research as per NEP 2020. Now therefore, **Government Raza P G College, Rampur** have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the co-operation of the both institutions.

### **Clause 1: Object**

Both HEI agrees to develop and execute the collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two institutions shall seek to promote academics in the area of Social Science and Humanities.

**Academic Collaboration Government Raza P G College, Rampur, and IFTM University, Moradabad** agree that the academic collaboration will be guided by principles listed below:

- a. Exchange of students by mutual agreement between both the institutes.
- b. Exchange of faculty members by mutual agreement between both the institutes.
- c. Collaborative research
- d. Organising and participation in joint project for fruitful academic outcome.
- e. Any other academic endeavour that augments the skills and capability of students and faculty members as mutually agreed upon.

### **Clause 2: Agreement**

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration which will be agreed upon mutually

### **Clause 3: Co-ordination**

Each HEI shall appoint one or more members of its teaching faculty to coordinate the programme on its behalf. Further, a Coordination Committee consisting of a programme coordinator from the side of **Government Raza P G College, Rampur**, and a programme coordinator from the side of **IFTM University, Moradabad** will periodically review and identify ways to strengthen co-operation between the two institutes.

### **Clause 4: Validity**

This Memorandum of Understanding shall remain in force for a period of Three years commencing from the effective above mentioned date. HEI may extend the term by written agreement signed by both after review.

### **Clause 5: Termination**

Either HEI may terminate the MoU by giving written notice of six months in advance to the other HEI. Once terminated, neither **Government Raza P G College, Rampur**, nor **IFTM University, Moradabad** will be responsible for any losses, financial or otherwise, which the other institutes may suffer. However, **Government Raza P G College, Rampur**

**Clause 6: Amendments / Modifications**

This MoU may be amended or modified by a written agreement signed by the representatives of both HEI.

**Clause 7: Adherence to Rules**

Participating staff members and students involved in any activities under this Memorandum must adhere to the rules and regulations of both the HEI.






**Clause 8: Legal Right**

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaborations especially to promote and strengthen the academics.

**Clause 9: Dispute Resolution**

In case, there be a dispute relating to any aspect of academic co-operation, Heads of Institutions of both the parties, namely, **Government Raza P G College, Rampur and IFTM University, Moradabad** will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

**Government Raza P G College, Rampur and IFTM University, Moradabad** welcome the establishment of this Memorandum for co-operation and jointly agree to the provisions as set out above.
